Minutes City of Mechanicsville SPECIAL COUNCIL MEETING March 24, 2025

The Mechanicsville City Council met in special session on Monday, March 24, 2025 at 102 N John Street, Mechanicsville. Mayor Andrew Oberbreckling called the meeting to order at 7:00 p.m. Council members present for roll call were Randy Brown, Brian Steele, Tracy Miller, and Doug Weber. Amy Miller seat vacant. Others present included Daniel Pike, Tyson Scott, Adam Paidar, Carla Barnhart, Pat Albaugh, Jean Miller, Kate Heffner, and Dave Furry.

CONSENT AGENDA:

Randy Brown motioned; Brian Steele seconded to approve the consent agenda including the agenda and the minutes from 3/10/25. Roll call vote: Ayes: Brown, Steele, and Miller. Nays: None. Weber abstained. Motion carried.

Appoint person to fill vacant council seat: Two letters of interest were received and read by the clerk. One being from David Furry and the second from Adam Paidar. Brian Steele motioned, Tracy Miller seconded to appoint David Furry to fill the vacancy. Ayes: Miller, Steele, and Brown. Nays: None Abstain: Weber Clerk gave Oath of Office to David Furry and he joined the council for the remainder of the meeting.

Set Public hearing on proposed budget April 14, 2025 at 6:30 p.m. Doug Weber motioned, Brian Steele seconded to set the date and time for the public hearing to adopt the budget for FY25-26. Ayes all. Motion carried.

Equipment repairs: Armor Equipment provided a quote of \$3281.62 for a curtain set, skimmer kit, fuse panel, draglink and labor to repair the street sweeper. Discussion on the Kubota mower being down at Kunau needing a second radiator installed in it, oil change, and blades replaced at a cost of \$1000 and will still have an oil leak. Questions about condition of other mowers being a John Deere and 2 Hustlers and a maintenance schedule for the mowers and trucks. The Kubota mows better than the Hustlers is why it is used over the other mowers. Dave Furry motioned, Brian Steele seconded to approve the quote for repairing the street sweeper. Ayes all. Motion carried. Discussion moved to disposal options for the Kubota mower, 3 pt blade for the tractor, and the Heineken snow plow without any brackets (stolen when truck was stolen). Options considered were listing on GovDeals.com, clerknet, sealed bids, or potentially scrapping. Council decided to table until next meeting to find out what it might cost to list.

Street Maintenance Seal coating proposal \$27,860.50: Proposal from LL Pelling to seal coat 125th, the Approach at Country View to 125th, and Cemetery Roads, Brian Steele motioned, Doug Weber seconded to approve the proposal. Ayes all. Motion carried.
