## Old business discussion and possible action on:

**Proposed amending ordinance 55.06 to add a scheduled penalty section for animal control violations.** Dee Cook motioned, Dee Taylor seconded to approve the third and final reading and adopt the ordinance as **"55.20 PENALTIES.** Roll call vote: Ayes: Cavey, Cook, and Taylor. Nays: None. Absent: Davis and Logue. Ordinance adopted.

**Ordinance 275 for zoning change from A-1 to C-1:** Dee Cook motioned, Pam Cavey seconded, to approve the third and final reading and to adopt Ordinance 275 to rezone Poduska property including Auditors parcel C from A-1 to C-1. Roll call vote: Ayes: Cavey, Cook, and Taylor. Nays: None. Absent: Davis and Logue. Motion carried

**Street Overlay project discussion and request from contractor for Mayor to sign waiver:** Mayor Butler updated the council on the grinding and the condition of the street underneath. Contractor felt that additional HMA would be needed in order to meet the initial specs, which would increase the cost by about \$104,000. In order to proceed contractor requested city to sign a waiver regarding the Straightedge and profilograph Pavement Smoothness, SUDAS specifications 7020 3.05; Core samples for thickness

and density testing; finished pavement density testing; and the minimum 1 ½ inch compacted lift thickness called for by IDOT Article 2303.02 C for ½" design Mix size. After much discussion, Dee Cook motioned to authorize the Mayor to sign with clarification of 2.2 and 2.4 items in the original bid specs. Dee Taylor seconded. Ayes: Taylor and Cook. Nays: Cavey. Motion approved. Davis and Logue absent.
